#### • DUES / LATE FEES.

HOA payment is due 1st of each month. If received after the 15th (regardless of check date), a 10% late fee (\$6) is added. Drop payment in brick mailbox by sidewalk to clubhouse (off Fox Lane). At 90 days past due, accounts may be sent to HOA attorney for collections and/or lien. (\$120 collection fee charged to homeowner, not HOA, when sent to Collections).

# **Trash / Recycling**

Recycling is TUESDAY

be put in garage or behind fence by evening. Yard waste in garbage can, bagged, or tied in 4 ft bundles.

No OIL or PAINT cans (unless absorbed by kitty liter). Needles to be in separate closed container labeled "Medical Waste".

Help our streets stay clean: pick up "free" papers and throw them in your trash if you do not want them. They make a huge mess on street when left out in weather and driven over by multiple cars.
