#### Rental Units

Reminder: Those with rental units need to notify Board in writing before renewing or signing a new lease to check on percentage limit. Great time to consider selling rather than renting!

#### • Clubhouse Rental:

Rental fee is \$200 (includes cleanup). \$50 reserves the date and \$150 balance is due 7 days prior to rental date. For those residents renting property in The Village: \$400 rental fee (includes cleanup after party). Call Karen at 770 -226-9111 to reserve clubhouse date.

## • DUES / LATE FEES.

HOA payment due 1st of each month. If received after the 15th (regardless of check date), a 10% late fee (\$6) is added. Drop payment in brick mailbox by sidewalk to clubhouse (off Fox Lane). At 90 days past due, accounts may be sent to HOA attorney for collections and/or lien. (\$120 collection fee charged to homeowner, not HOA, when sent to Collections).

## **PLEASE HELP**

- Park in garage and on your driveway before parking on street-be considerate of neighbors; move vehicle to driveway as soon as there is room on your driveway.
- Stop signs mean stop—not just slow down or roll through intersection.
- Slow Down on all streets!!!
- Clubhouse parking lots are for clubhouse or pool use. Call or email Board member (via website) to ask permission to park for specific reason (not overnight or if clubhouse rented)
- U.S. Mail—unfortunately mail gets misdelivered due to same house numbers on different streets. Please put in proper mailbox if you receive wrong mail. If returned to PO, there is excessive delay in delivery.
- "Free" papers make a mess. Use them or put in trash can. Don't walk / drive over them until they are mush on the streets / driveway
- Put trash cans behind fence or in garage by evening on Tuesdays & Fridays.
- Your own Commercial vehicles must be parked only in garage -NOT on street or driveway
- Some areas are off limits for play or dog walking. These include the creek banks (rocks placed for erosion control; walking on them may cause granite rocks to fall; snakes love to hide there); entrance area grass & berm-please do not walk dogs there—if one dog uses it, then all dogs want to go there and it burns the grass; clubhouse lawn is not a ball field or bike path.
- Respect private property of your neighbors-kids should NOT be playing on or crossing other's driveways / yards; dog walkers should not

allow their dogs to go up on other's property.

Signed Consent Forms still needed to meet two-thirds vote to update Leasing Amendment to max of 15% rental units and two years living in home before asking for permission to rent.

## **CDC tips for dealing** with COVID-19

Lead by example. Teach and reinforce preventative health measures like frequent handwashing, disinfecting high-touch surfaces and laundering clothes often

Play it safe. If you live in the same household as high-risk individuals, limit your children's contact with them. Postpone non-essential visits to see older family members and friends. Prepare when going out in public. Children two years of age and older should wear a cloth face-covering over

their nose and mouth when in a community setting. Make time to talk. Use age-

appropriate language to talk to your children about the COVID-19 outbreak. Address their worries, answer guestions and share facts from reputable sources.

Watch for signs of stress. Look out for changes in your child's eating behaviors, excessive worry or sadness, and trouble paying attention. Say no to playdates. To help slow the spread of COVID-19, your children should not meet in groups or play with children from other households while school is out.

Create a flexible routine. During the week, set consistent times to wake up and go to sleep. Balance the school day with both learning and free time. Make learning at home fun.

Incorporate creative activities into the school day like drawing, painting, puzzles and journaling.

Focus on healthy nutrition. Feed your children healthy meals and snacks throughout the day to boost and maintain their natural immunity. Help kids stay active. Encourage outside playtime at home (not public playgrounds) and physical activity in your children's everyday routine during the week.

Stay connected. Help your children make virtual visits to friends and family over the phone or video chat.
